

VILLAGE CREEK BONANZA

The Conservation Fund has scored again -- in acres. TCF will sell 1500 acres to TP&WD for \$650,000 -- a bargain bonanza! Commissioners agreed Nov. 5 to purchase the tract that will more than double the size of Village Creek State Park. The expansion provides more recreational opportunities and protects diverse habitat. VCSP may enter an agreement with NPS allowing access to several miles of the creek.



As indicated on the map, a 900-acre tract will become part of the Big Thicket National Preserve that's within their authorized administrative boundary.

PYRAMID MAGNOLIA PROJECT

On a BTA field trip last May in Newton County participants visited a 296-acre tract with populations of the rare Magnolia pyramidata. Those participating represented several groups who felt strongly that the area should be protected.

A campaign has been launched to purchase (or obtain a conservation easement) on the site.

Those involved to date are the BTA, Big Thicket Natural Heritage Trust, Magnolia Garden Club, the Beaumont group of Native Plant Society of Texas, Nature Conservancy, and Outdoor Nature Club. Several college student groups are participating. The goal is \$250,000. At the BTA general membership business meeting on Oct. 10, the BTA authorized contributing \$10,000 for the project.

Flora of North America states that the magnolia is "very local and nowhere abundant." The Center for Plant Conservation indicates that the tree is threatened but that there is no formal management plan. Consider making a generous gift for the project. CONSERVATION OUTLOOK

NEWS FROM NPS-BTNP

Appropriations: Congress has appropriated \$5,000,000 for land acquisition in FY2010, which should complete the 1993 Addition Act.

NPS Director Appointed: The new NPS Director is Jonathan Jarvis, a 33-year veteran, formerly Pacific West Regional Director, whose experience includes parks in Alaska, Idaho, Washington state, and California. Jarvis will now be responsible for 58 national parks and 333 monuments, preserves, historical sites, seashores, etc. He will be dealing with "a formidable list of challenges," according to Jonathan Hiskes in Grist, including effects of climate change (wildfires, receding glaciers, rainfall changes and flooding. His goals include connecting all Americans to their national parks and addressing a staggering maintenance backlog.

TRINITY RIVER N.W.R. CONSERVATION PLAN: The National Wildlife Refuge has scheduled three public meetings to solicit input for a Comprehensive Conservation Plan (CCP). The Plan describes desired future conditions and provides long range management guidelines with a watershed, ecosystem and landscape approach. The meetings begin at 7:00 PM as follows:

BLACK BEAR CONSERVATION: East Texas Black Bear Task Force members will meet December 15th – 16th in Saratoga at the BTNP Field Research Station. A five-year review of

conservation and management efforts is on the agenda.

An ETBBTF Black Bear Educators Workshop will be held Saturday, February 27, 2010 at the Big Thicket National Preserve Visitors Center and will be taught by Rachel Rommel and Victoria Sokol from the Houston Zoo with help from the National Park Service interpretive staff.

TAXA TALLY TO DATE: Over 8200 specimens in 17 different taxonomic groups have been identified; over 35 new species known to the preserve; 57 new species known to the state of Texas; and 5 brand new to science! Seminars and workshops in September and October were well attended and generate a lot of enthusiasm for the Thicket of Diversity: Fishes Seminar, 30+attending; Fish Identification workshop. 20 volunteers participated with training and field work; Pyrenomycetes Fungi workshop, 8 volunteers participated with training and field work
